- We are working on getting the high school registration drives completed. Letters
 have been sent to all of the schools. We are following up with phone calls and
 emails.

- The MPA project is taking most of our time: we have processed 3,559 pages.

 At next month's meeting, you will be asked to consider the appeals of rejected VR applications. These are people who checked the box of the VR form that they had been convicted of a felony. Mostly, these are people who didn't read the form correctly and checked the wrong box; some are truly felons.

Operations Department

- Most of the activity of the last month has been in holding the TN Senate District
 32 Election.
- Commissioner Lester and Tate appointed Ronald Boozer as the full-time Democratic machine technician; he replaces Matt Lucas.
- We have done four private/school elections since the last report.

Administrator

- You might have noticed that the base of the sign has been installed. It became
 very obvious that the sign was going to prevent people from seeing traffic coming
 from the south; since much of the traffic coming from the south is large
 equipment like dump trucks or rapidly moving law enforcement vehicles, this is a
 problem. The base will be moved.
- As of yesterday, our website has had 880,170 views; it published 1/31/2018.
 Contrast this with our old website page views; typically it was around 100,000 for a year. There have been two upgrades; the interactive GIS maps published and linked and EasyVote Campaign Finance has had a huge improvement in speed.

- SB 1356/HB 1355 Compensation of AOE. This bill is still alive but has not been scheduled for a committee hearing, so my guess is that it is dead. The fiscal note was not very detailed and probably overstated the cost; this would really have benefited small counties and would have little impact on the larger ones.
- HB 145/ SB 193 Would allow a person who registered by mail to apply to vote absentee by appearing at a county election commission office. I think this is a low burden, common sense approach to the problem of students who register online. The Senate bill will be heard in Committee today; the House Bill is scheduled for tomorrow.
- HB 195/SB 74 Would eliminate the use of the full SSN on election records. Both have passed on second consideration; neither bill is scheduled for committee hearing.
- HB 312/ SB 240 This would establish election day registration. If this is done correctly, it can be a huge improvement in the process since it can eliminate provisional ballots. 17 States have some form of Election Day registration. Both have passed on second consideration; neither bill is scheduled for committee hearing. I suspect this is dead; which is too bad, same day registration can be done well and benefit voters and taxpayers.
- HB 554/ SB 825 This would require us to establish an early voting location on college campuses with more than 8,000 students. The Senate bill will be heard in Committee today; the House Bill is scheduled for tomorrow. TACEO opposes

this bill. I oppose this bill; we don't have enough equipment, supervisors or people to accomplish this, so it has a high fiscal impact for Shelby County.

- HB 1432/SB 1012 This would require the use of precinct based optical scanners for elections. Both have passed on second consideration; neither bill is scheduled for committee hearing. There is no fiscal note available for this bill; the fiscal impact would be huge. TACEO opposes this bill; there are better solutions for large counties and we should at least join this century by allowing digital scan rather than requiring technology that is older than I am.
- HB 46/ SB 761 Would require us to have early voting on Sunday. This bill is dead.
- HB 547/ SB 589 Would restore the voting rights for most felons without condition. Both passed on second consideration; HB 547 is scheduled for committee hearing tomorrow. SB is not scheduled for committee hearing.
- HB 1273/ SB 1500 Would have required closed primaries and registration by party. This bill is dead.
- I will be a table moderator, along with Jackson Baker from the Memphis Flyer for the upcoming League of Women Voters Soapbox dinner on March 26, 2019. We will be at the table discussing alternative voting processes, same day registration, and potential legislation.
- Deputy AOE Young continues to put his focus on issues related to security, particularly in educating our staff.
