Meeting was adjourned at 6:08 pm.



Administrator of Elections Monthly Report October, 2019

Voter and Candidate Services

- We received 7,796 voter registration forms between the September 3rd cut-off for Memphis and the deadline for registration in the run-off. This was an unusually high number thanks to Facebook running registration campaign around National Voter Registration Day.
- UOCAVA ballots for the run-off were sent by the deadline.
- Campaign finance notices for the third quarter were sent on time. Candidates who are in the run-off will file an additional set of pre-general reports. All other candidates need to file quarterly reports until they report a zero balance. A list of those candidates who have filed and who owe reports is attached. All reports that we are received are available on the EZ Vote website; the link is on our webpage.

Operations Department

- We are in full on election mode so aside from our normal election activities there isn't anything to report.
- The public test of election equipment for the run-off is at 9:00am on Thursday, October 24th. Early voting begins on October 25th for the run-off.

Administrator

- The United States was able to reach an agreement with the Universal Postal Union, so UOCAVA ballots are not affected.
